SUB: AMENDMENT AGAINST TENDER NO. SDG8056P19/07

1.0 THIS AMENDMENT is issued to bring following changes in the ANNEXURE II (**BID EVALUATION CRITERIA (BEC)/BID REJECTION CRITERIA (BRC)**) of the subject tender:

a) The **clause no. (I)-A.1-2.0-i(a)** has been changed as follow in lieu of the existing:

The bidder shall have experience of successful execution of past supply for minimum 50% quantity (to be rounded off to next higher integer) of each tender item of same or higher size & rating (class, WP, PSL, PR etc) as specified in the tender, in last 5 years preceding the original bid closing date of the tender, to any Oil & Gas Industry or service provider to an E&P company, either by themselves or through their agent/dealer/distributor/stockiest/supply house.

b) The **clause no. (I)-A.1-2.0-ii(b)** has been changed as follow in lieu of the existing:

Additionally, the bidder himself shall have experience of successful execution of past supply for minimum 50% quantity (to be rounded off to next higher integer) of each tendered item of same or higher size & rating (class, WP, PSL, PR etc.) as specified in the tender, in last 5 years preceding the original bid closing date of the tender, to any Oil & Gas Industry or service provider to an E&P company, provided either from the same OEM (principal) or from any other OEM.

c) A **new clause no. (I)-A.1-2.0-iv** has been inserted as follow:

NOTE: The Purchase Order date need not be within 5 (five) years preceding original bid closing date of this tender. However, the execution of supply should be within 5 (five) years preceding original bid closing date of this tender.
