CORRIGENDUM NO. 3 DATED 24.05.2022 to IFB No. CDI9922P22 for ‘Renovation and Expansion of Electronic Workshop of Instrumentation Department’.

This Corrigendum is issued to notify the following changes:

1. Extension of dates:
 - Last Date of Bid Submission is **31.05.2022 (11:00 Hrs IST)**
 - Last Date of Bid Opening is **31.05.2022 (14:00 Hrs IST)**

2. Clause No. 4.6 and 4.8 under Clause No. 4.0 in Part-II ‘TERMS OF REFERENCE AND TECHNICAL SPECIFICATIONS OF EQUIPMENT/SCOPE OF WORK’ of the tender have been modified as below:
 - i) **Clause No. 4.6: Door in the full height partition:** Providing and fixing flush door of size 750mm x 2175mm including fitting including the cost of labor, steel hinges, locks, latches, door stoppers, door closures, handles and finished with 1.0mm thick veneer sheets on both sides on both sides complete with melamine polish, etc. A cut-out shall be made in the partition as per the design blending with the partition and shall be fitted with 4-6 mm thick clear glass finished with timber lipping and complete in all respect. The Contractor shall have to provide, fixing 38 mm thick factory made ISI marked 38mm thick flush door of size 750mm x 2175mm for the entrance with panelling on the walls and door frames including finishing with **4.0 mm thick veneer sheet** on both sides and fitted with 04 nos. M.S. oxidized SS butt hinges of size 100mm x 75mm x 3.55mm with necessary screws etc., 01 no. of SS tower bolt of size 200mm (L), SS 6 lever handle lock (Godrej, IPSA or equivalent) complete with all labor and material including the cost of steel hinges, locks, door stoppers, hydraulic door.
Quantity: 1 no.

 - ii) **Clause No. 4.8: New Door in the existing partition:** Providing and fixing flush door of size 750mm x 2175mm including fitting including the cost of labor, steel hinges, locks, latches, door stoppers, door closures, handles and finished with 1.0mm thick veneer sheets on both sides on both sides complete with melamine polish, etc. The Contractor has to make necessary provision (cut out) in the existing wooden partition to provide a door as per the design blending with the existing partition and shall be fitted with 4-6mm thick clear glass finished with timber lipping and complete in all respect. The Contractor shall have to provide, fixing 38mm thick factory made ISI marked 38mm thick flush door of size 750 mm x 2175mm for the entrance with panelling on the walls and door frames including finishing with **4.0mm thick veneer sheet** on both sides and fitted with 04 nos. M.S. oxidized SS butt hinges of size 100mm x 75mm x 3.55mm with necessary screws etc., 01 no. of SS tower bolt of size 200mm (L), SS 6 lever handle lock (Godrej, IPSA or equivalent) complete with all labor and material including the cost of steel hinges, locks, door stoppers, hydraulic door.
