## **CORRIGENDUM FOR PRE-BID CONFERENCE**

### **A) Pre-Bid Conference:**

(1) It is for information of all bidders that, against tender no. SDI1475P20, a Pre-Bid Conference with the vendors will be held on 11.09.2019 (Wednesday) from 9 AM onwards in the premises of L&D Dept, MTDC, Oil India Limited, Duliajan to discuss on the technical specifications and other terms and conditions of the tender. All the vendors who register themselves against this tender will be eligible to attend the Pre-Bid Conference.

(2) Clarification on the technical specifications and other terms & conditions of the tender shall be provided to the vendors during the Pre-bid Conference. Vendors should come fully prepared to the Pre-bid Conference and submit their queries to OIL in the Pre-bid Conference for clarification. The set of queries shall be sent to OIL at least 5 days before the Pre-bid Conference (ie within 06.09.2019) for study by OIL.

(3) Any changes in the technical specifications and other terms & conditions of the tender arising out of discussion in the Pre-bid Conference shall also form part of the tender document. In the Pre-bid Conference specifications, terms and conditions of the NIT will be frozen and no request for amendment to NIT shall be entertained after the pre bid conference.

(4) Vendors shall depute representatives who are competent enough and authorized to take on the spot decision. At the most 02 (Two) representatives from each vendor shall be allowed to participate in the pre-bid conference. All costs for attending the pre-bid conference shall be to the vendors' account.
