**CORRIGENDUM-3 DATED: 29.07.2020 TO TENDER NO. : CDC3707P20**

**Description of work:** Construction of approach road, plinth, road over plinth, construction of CC/ RCC foundation to suit VFD (E-2000) in any location in Chabua & Tengakhat Area in Dibrugarh District including supply of all materials except Cement, drum sheets.

This Corrigendum is issued to all concerned bidders of the aforesaid tender to notify the following:

1. OIL Registered “A” Class Civil Contractors are exempted from the work experience criteria (BEC Clause No. 2.1.1) and submission of bid security against the aforesaid tender. However, they are not exempted from the financial criteria (BEC Clause 2.1.2) and all other qualifying criteria as stipulated in BEC/ BRC and accordingly, they must submit the necessary documents against the applicable criteria.
2. Mention of **UDIN (Unique Document Identification Number)** is mandatory for all Certificates issued by Chartered Accountant in Practice w.e.f. February 1, 2019.
3. The revised BEC/ BRC & Annexure-II to the tender (prescribed format for Certificate of Annual Turnover and Net Worth) are uploaded in the “Amendments” folder in E-Tender portal and relevant changes are highlighted in yellow.
4. Bid Closing and Opening Date & Time for the above mentioned tender are extended to **06.08.2020 (11:00 Hrs Server Time)** & **06.08.2020 (14:00 Hrs Server Time)** respectively. Bidders are permitted by system to withdraw their bid or make any changes in their bid prior to the extended Bid Closing date and time. But no changes or withdrawal would be allowed by the system once the due date and time for submission of bids has been reached and bids are opened.
5. In addition to the manner as defined in tender, Bid Security can also be submitted in the form of Bank Draft or Cashier’s Cheque or Banker’s Cheque or Fixed Deposit Receipt (Account OIL INDIA LIMITED) in favour of “Oil India Limited” payable at Duliajan, original of which should reach the office of CGM-Contracts on or before 01:30 pm (IST) of the scheduled (extended) bid closing date of the tender. A scanned copy of the same should also be uploaded along with the Technical bid.

Bidders can also deposit the BID SECURITY through NEFT or RTGS mode on or before bid closing date and time to designated account of OIL as mentioned below:
